

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.ashburnallergy.com> and Ashburn Allergy, PLLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ashburn Allergy, PLLC include <https://www.ashburnallergy.com>, Ashburn Allergy and <https://www.ashburnallergy.com>. The Ashburn Allergy website is a general purpose and medical information site. By using the Ashburn Allergy website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Ashburn Allergy may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Ashburn Allergy collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Ashburn Allergy may also use your personally identifiable information to inform you of other products or services available from Ashburn Allergy and its affiliates.

## Sharing Information with Third Parties

Ashburn Allergy does not sell, rent or lease its customer lists to third parties.

Ashburn Allergy may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Ashburn Allergy, and they are required to maintain the confidentiality of your information.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Ashburn Allergy. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Ashburn Allergy website.

### **Use of Cookies**
